PURPOSE OF MEETING

The purpose of this Public Information Center Meeting was to inform the public of the conceptual alternatives and to solicit public input and comment on the proposed Preliminary Preferred Alternative (PPA). (See attached Meeting Notice)

MEETING SUMMARY

1. A total of twelve (12) individuals attended the meeting as indicated on the Sign-In Sheets and three individuals who chose not to sign in. A total of fourteen (14) project team members were in attendance to present information and assist with public questions, including Khalid Shaikh, from NJDOT Bicycle & Pedestrian Program.
 - The meeting was designed as an open house format with display boards providing aerials maps of the CR537 project study area, environmental screening, the Conceptual Alternatives, the Alternatives Comparison Matrix indicating the Preliminary Preferred Alternative (PPA), and the Local Concept Development process flow chart.
 - Project team members were available to answer questions.
 - A Project Information Update handout and blank Monmouth County Comment Form were distributed to the general public upon sign-in to the meeting. The Comment Form could be completed to hand in at the meeting or could be faxed, emailed or mailed to Monmouth County within the next 30-day comment period (Blank Comment Form attached).
2. At 6:30 p.m. Martine Culbertson, Community Involvement Facilitator, opened the brief presentation by welcoming attendees on behalf of Monmouth County, and the cooperating agencies of North Jersey Transportation Planning Authority and the New Jersey Department of Transportation.
3. After introductions by the project team members, Daria Jakimowska, Monmouth Project Manager, provided information on the project status and schedule. Due to increased congestion, access and safety issues; this project was developed to address the traffic and pedestrian concerns

on this section of Route 537. We are in the Concept Development phase and looked at alternatives, which will be presented in the PowerPoint presentation to propose a Preliminary Preferred Alternative (PPA) to move forward to the design phase. The presentation will be posted to the Monmouth County web site by end of the week.

4. Bruce Riegel, H&H Project Manager, presented an overview of the project work efforts to date: the existing deficiencies in the corridor, the approved Purpose and Need Statement, and the proposed conceptual improvements, as Concepts 1, 2 and 3.
 - (a) Based upon input received at the Community Stakeholders Meeting No. 2, Concept 2 and Concept 3 were developed to address various additional improvements at certain intersections.
 - (b) The data has been entered into the Alternatives Comparison Matrix to examine which of the concepts best meets the project purpose and need and the objectives as listed while minimizing environmental and right-of-way impacts.
 - (c) Bruce Riegel explained the Level of Service (LOS) for the operation of signalized intersections, which are rated from A to F. When proposing improvements for an intersection, the County looks to achieve LOS D for all movements during peak hours. Off peak the intersection would operate better, but due to limitations in acquiring extensive amounts of right-of-way, it is a compromise or balance between amount of lanes and property required to achieve the operational improvements. Safety and appropriate turning radius are also considerations in the operation of an intersection.
5. Bruce Riegel provided information as indicated on the Alternatives Comparison Matrix. He explained the potential improvements verses impacts to each concept, most notably at the intersection of Wemrock Road and Stillwells Corner Road, a key intersection in the RT537 corridor. Based upon the needed improvements at the key intersections, the Preliminary Preferred Alternative (PPA) proposed by the project team is Concept 3.
6. For next steps, Bruce provided information on the project schedule, as listed on the Project Information Update Handout and on the PowerPoint presentation.
 - The presentation will be posted on the Monmouth County web site.
 - The Concept Development Phase is scheduled to be completed by end of April 2013 with a Preferred Alternative.
 - Once the public meetings are held and a PPA is favored by the community, resolutions of support for the PPA will be requested by the Township of Freehold and Borough of Freehold so to complete the Concept Development phase documentation.
7. The meeting was opened for any questions or comments from attendees. The following questions and comments were noted:
 - *Question #1:* How wide will the travel lanes and shoulders be?
Response: The outside lanes will be fifteen feet (15') which is twelve feet (12') for vehicles and three foot (3') wide shoulders provided for bicyclists.
 - *Question #2:* Does the level of service D mean all the time or when?
Response: The level of service is rated for the operation of the signal during the peak traffic period of the day. So at 4:00 a.m. with little or no traffic, most intersections in the corridor would be level of service A. On the Alternatives Comparison Matrix, level of service D, is the peak period based

on future condition (Year 2032) traffic volumes and analyses. The traffic analysis is projected 20 years out in the future.

- *Question #3:* Is the funding in place and what effect does the Federal sequestration have on this project?

Response: There is funding in place for this Concept Development phase and FHWA transportation funding is generated primarily by gasoline tax, so the sequestration does not directly impact funding for this type of project.

- *Question/Comment #4:* Have travel demand measures been included in the consideration of improvements to the Route 537 corridor?

Response: No, not directly since they are considered as part of the traffic projections used during the traffic analysis. Similar to examining potential development in the corridor, estimates are used but not specific figures since it is not certain if they will occur.

8. In summary, Joe Ettore, Monmouth County Engineer, thanked everyone for attending the meeting and providing comments. Daria Jakimowska thanked the Freehold Township for hosting the meeting here at the Senior Center and noted that Project Team members would continue to be available near the display boards should anyone have additional questions in looking at the information provided.
9. In closing the presentation, Martine encouraged attendees to submit their comments or any additional questions after the PIC meeting on the blank Comment Form or if in letter to the attention of the County Engineer, Joseph Ettore.

 - Future information on the project will be posted on the Monmouth County web site, once the Concept Development phase is completed and the County looks to move the project to the Design phase.
10. The PIC meeting adjourned at 8:00 p.m. No completed PIC Comment Forms or letters were given to the project team at the PIC meeting.

Additional Notes

11. A total of four PIC Comments were received by the County. One prior to the PIC meeting and three after the PIC meeting was held, during the 30-day public comment period.
12. The PIC Comments received are attached with personal information redacted to this summary report and the same has been attached to the summary report for Freehold Borough.

Subject: Rt. 537 Roadway at Stillwells Comer Road

I think changing the middle lane from straight only to straight and right on Stillwell Corners Road heading North will help traffic flow. This allows drivers to be in the middle or right hand lane to make a right onto Rt. 537 East. Since Rt. 537 is a two lane road, for those turning right onto Rt. 537 East, the middle lane driver can make a right onto the left hand lane of Rt. 537 while the right lane driver can make a right onto the right hand lane of Rt. 537. This may require lane markers but it would vastly improve the traffic flow for those wishing to make a right hand turn onto Rt. 537 East as the line of traffic making a right is considerably more than those going straight or left. This is especially important because there is a No Turn on Red sign.
